Looked into 501c3 - this is a complicated process and will take a lot of research and info needs, would like to hold off until a laptop is in place and she's gained a little traction in her role.

From Barrett: Clarification on the OMRA Leg. account being the Savings account referenced. Would like to propose we have a benefit/risk assessment on the desire to go 501c3 as there are a lot of restrictions involved.

Tawnjai will get more info and share.

ACTION ITEM: Have 501c3 benefit/risk assessment done and presented by end of Q2 so if we decide to proceed we can have the process completed by Fall (Late Q3).

Tawnjai is looking to move as many bills as possible to ACH payment vs. debit card to ease the handoff when the next transition is made as Treasurer.

### Rec.: Rob Wise

Another trail date two weekends from now. Enjoying these a lot and reminder that clubs and individuals can reach out and host one of these work parties for events, favorite riding areas, etc.

Reid: This is turning out to be a great program that the OMRA and it's getting lots of positive feedback.

Dave: this is what the OMRA is all about in my opinion, this is great.

Rob: Talked to Dustin at Chicken and Guns and he may have a spot to utilize for meet ups for these events, if they are in the TSF.

# Membership: Josh

Up to 114 Members in LiveLaps right now. Would like to request weekly or bi-weekly blast on Social Media to keep excitement up and members rolling in.

Gary: Does the number include previous RaceDay members?

Josh: No, RaceDay members are being reimbursed and then they have to create a new account

Justin: there are 88 people that bought 2-years and 3 with lifetime memberships, we just need to cross reference those. I've already transferred approx. 10 over already.

Lindsey: Please utilize us as resources to get the hard stuff done! We want to deliver a simple product.

Ross Dillon: Offering my services in Excel cross referencing and work - I can make this all less manual.

# Legal/Leg.: Barrett Brown

In a bit of review right now for some fire danger. The dept. is reevaluating all of their policies on public access. Right now there's a big push to close at a low level fire risk - basically all summer. This is not a scientific approach by them, it's a risk aversion. Public voices will be needed to defend our access.

Reid: Current trajectory of that conversation is riding would be allowed in level high from 10 pm to 1 pm, so through the night.

We will keep posted on this.

About \$650,000 in grants after a lack of spending last year. Applegate got a quad to replace them. Huckleberry got a grant to expand camping area and more. Add a few miles of single track. La Pine given a grant to add a staging area right off the road. Mt. Scott got some purchase agreements. Hood river received a grant for staging areas as well.

Because of COVID - ended up with \$8 million in excess. We really need to spend this to stay under the radar so some new acquisitions or expansions are to be expected.

With all the excitement around TSF - Fully funded with ATV Program dollars is a NOVAC (trail add? Barrett - please provide notes via email, July 8th/9th/1-th event details?).

### Marketing: Justin Lewis

We've talked about most of it. The preliminary and serious stuff is out there and marketed. Still work to do in getting sponsors, get race/event posters flowing and posted, this gets people excited.

Thanks to Rob and Lydia for posting the things to the website! It's so nice to receive the notification email with info that I didn't yet have!

General traffic based on sign ups and things is slow, getting the series underway and continuing our social media push will help.

#### YSEP: Dan Jordan

Things are rolling, first class coming up this weekend! Lots of people want this so that's good.

Insurance was renewed but went up quite a bit this year - \$6,200 (up from \$4,800 year before). State Parks usually helps us with this. Up to \$4000 in the past, I reached out and asked for a bump and got approval for \$5000 for insurance reimbursement. Tawnjai is getting Jeff Trejo the invoice for this.

In process of sending out final checks for Q3 and Q4 of last year, Jeff is reviewing and when that gets back we will get checks out.

Lastly, since there is a lot of money in the ATV fund, we are in the process of getting all new motorcycles and ATVs from the state. Sent in a wishlist and it got approved! Not sure if it will come out of this biannual or next. They are very happy with how the program is going and are very supportive.

I've been storing the inventory in a 30 ft container that I purchased, I now need that. I will write a proposal to purchase a new container as we need somewhere safe and dry to store this stuff all winter.

#### VP - Reno Marr

Banquet is wrapped aside from if we are going to do a silent auction or not. Catered by BBQ - probably not going to do any PowerPoints or stage or anything.
